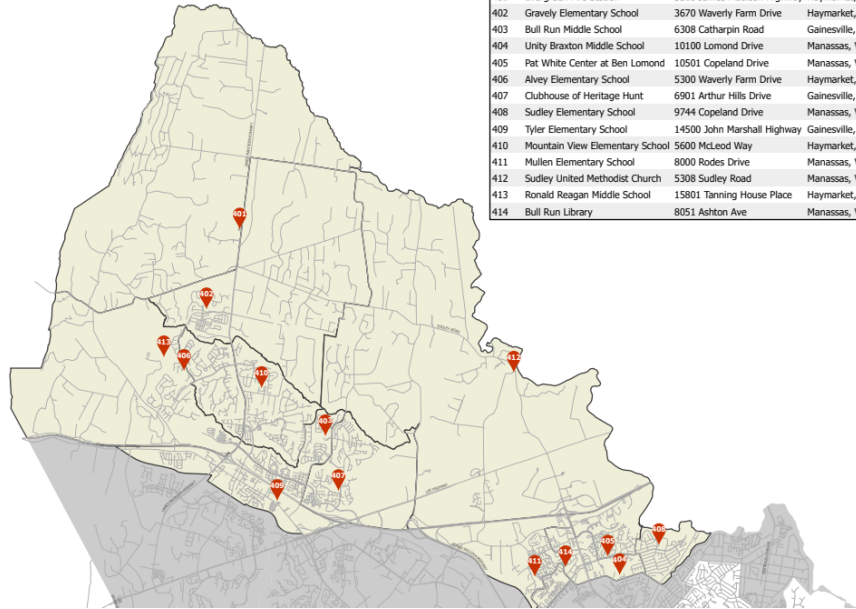

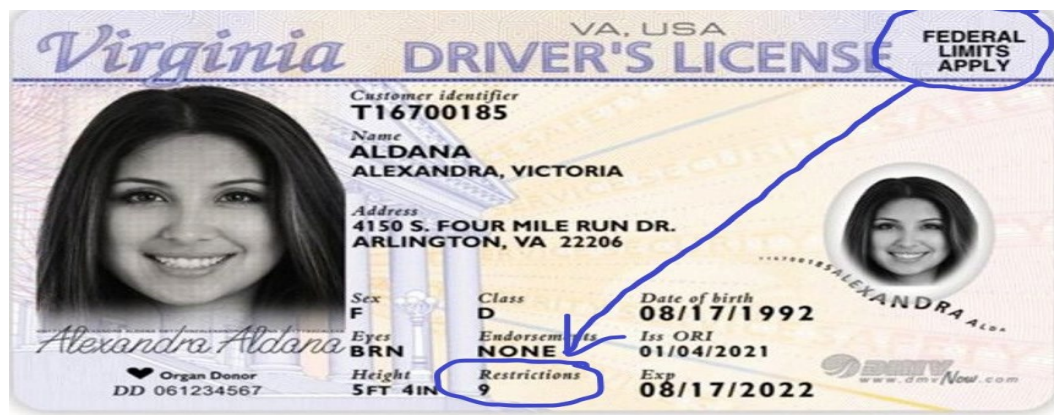

# Important Manual Changes

**There is a handout that lists all changes.**

- Only the paper Provisional Log.
- Only one poll watcher per party between 5 am – 6 am.
- Hang one signed copy of zero tape on wall near machine.
- Pollbook Check-in Procedure.
- Driver Privilege Card.



Driver Privilege cards are expressly excluded from the list of acceptable forms of identification.

## DRIVER PRIVILEGE CARD

To identify this type of license, you must see ALL of the following - (1) "Federal Limits Apply" in the top right corner, (2) "9" listed under Restrictions in the bottom middle of the license, and (3) on the back under Restrictions the words "LIMITED DURATION."

Ask voter for another ID from the acceptable list. Otherwise, they can use the ID Confirmation Statement. If the voter is on the pollbook, they will vote on the machine.



# What's New

- Paper Pollbooks – Good job on using the paper pollbooks. Didn't expect it.
- Statement of Results (SOR)  
Part F – Don't write passwords
- Don't pull wires from Merlin
- Pollbooks – Ensure the numbers increase when you check voter in.
- Pollbooks – When you check a voter in **RED** means “ready to vote.”

# What's New

- Pollbooks – Chief, if you spoil a ballot for a voter who tells one of the Officers “I don’t want to vote,” uncheck them on the pollbook.
- Pollbooks – If you are having sync issues only use one Pollbook and call HQ.
- Fled Voter – If you discover an unattended ballot in the precinct, spoil the ballot and make SOR Part F entry.

# What's New

- Affirmation of Eligibility – Why do we use it? Not for SDR
- Affirmation of Eligibility – If it is completed, the voter WILL vote on the machine.
- Same-Day Registration – Voter not on Pollbook in your precinct. Voter has moved into your precinct. If unsure, call the Office at 703.792.6470.

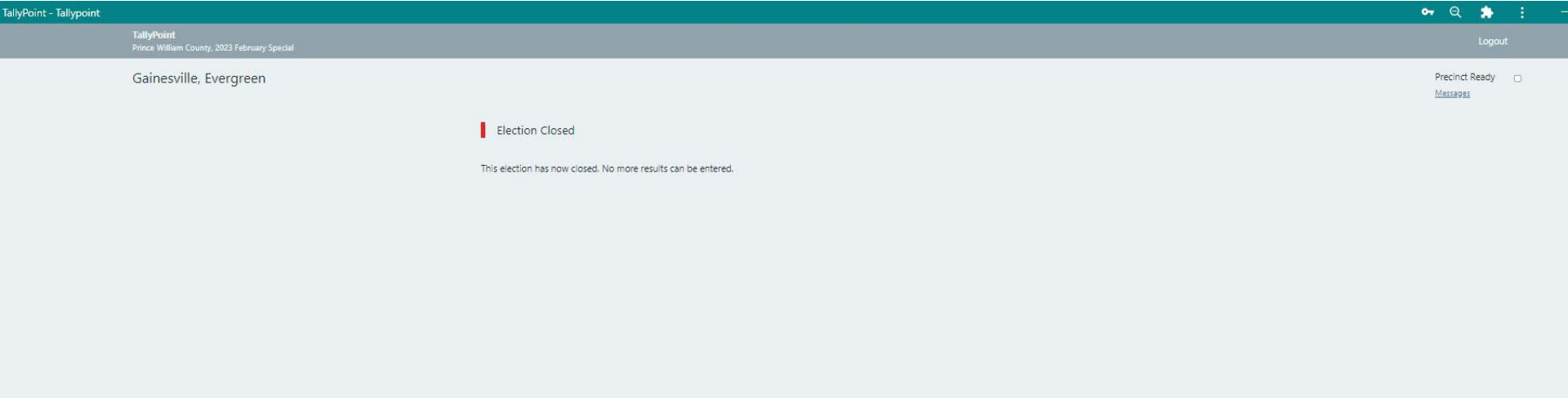
